

## Membership Details

### Basis of Fees:

Taxes paid to the City of Norwalk

- Income tax with pay stub or tax form
- City property tax with tax form
- Residency in City of Norwalk w/ proof of address

### Description of Categories:

- **Family** = Max of 2 adults and their children under the age of 18 or full time college students under the age of 24 living in the same household.
- **Adult** = High school graduate to age 64.
- **Student** = Youth under 18 or full time college student 24 or younger with current ID OR full-time military with ID. Adults 25 and older receive pass discounts with current class schedule or ID.
- **Senior** = Person 65 or over.

### Pass Procedure:

- Give information to the front desk.
- Review computer print out to verify information.
- Computer assigns a number to each family member.

### Reminders:

- Proof city tax is paid OR proof of residency must be shown each time fees are paid.
- All corporate passes must show proof of employment every time a pass is renewed.
- All pass members can schedule a FREE appointment to learn how to properly use the exercise equipment. Inquire at the front desk to schedule an appointment.

### EFT (Electronic Fund Transfer)

Annual memberships can be paid by having a monthly fee automatically deducted from your checking account.
